You must still follow the instructions given on the back of the (pink) summons, but **do not** include any payment when you mail in your summons. If you decide to plead Guilty or No Contest, you will be notified of the amount of your fine by mail.

\* Fine amounts represent the standard fine and penalty assessment normally imposed by the Court. The Court, however, may assess a different fine, may reject your plea and may order you to appear in person to answer to the offense charged. New Hampshire is a member of the Non-Resident Violator Compact. If you fail to answer the Summons and are an out-of-state driver, the registry in your state will be notified and your driver's license may be suspended.

**HABITUAL OFFENDER NOTICE**  
Numerous motor vehicle convictions may result in loss of license and possible imprisonment.
